



## Hit Me Blackjack New Member Promotion Rules

1. Must not be a current Genting Rewards Club Member at Resorts World Casino New York City (RWNY) to be eligible. Genting Rewards membership is free to all patrons who are 18 years of age or older who present a valid state or federally issued picture I.D. at the Genting Rewards booth. No purchase necessary.
2. Promotion information and rules can be obtained from Genting Rewards and by visiting [www.rwny.com](http://www.rwny.com).
3. All new members who are not qualified for another program will participate to a Hit Me Black Jack touch screen game to win up to \$1000 (\$100 X 10) in free play on the day that they sign up for their Genting Rewards card.
4. Guests who win the \$1,000 in free play will be awarded \$100 free play on the date they sign up and \$100 free play each week after earning 20 points for 9 consecutive weeks.
  - A maximum of 10 vouchers 10 X \$100 in free play will be awarded during the 10 week period. Limited to one redemption per week.
  - Unclaimed \$100 free play for each week will be forfeited and do not carry over to another week.
5. New members can also redeem a \$10 dining voucher after earning 50 points on the same date.
  - Guests that qualify for the new member offer must utilize the free play and their dining voucher on the day that they sign up.
  - New Members participating in a bus program can choose the new member or the bus program offer. The offer that is not chosen is forfeited.
6. Guests can only qualify for the new member offer one time. Duplicate accounts or replacement accounts will not qualify for the new member offer.
7. Offer is non-transferable and has no cash value.
8. Offer will be available at a Genting Rewards Kiosk after verifying the prize on the winning ticket. Offer must be redeemed from the kiosks. Free play utilized within the gaming day that the sign-up was completed.
9. Only the guest identified on the voucher will be eligible to claim the offer. Vouchers presented by a person other than the redeemer will be voided and the guest may be rendered ineligible for future promotions.
10. Malfunction of the Genting Rewards Kiosks or vouchers that do not register must be reported immediately and within the parameter of the promotion time.
11. Free play rewards are intended for use by the Genting Reward account holder that has the offer redeemed from their account. Any use of the offer by someone other than the account holder is not allowed and could render the account ineligible for future offers.

12. Use of free play only with no additional play may reduce or eliminate future offers based on historical play.
13. Vouchers and points are non-transferable.
14. All vouchers are void at the end of each designated promotion period.
15. Falsification of any information renders the winner ineligible for the rewards and forfeits any claim to the reward.

Eligibility: The following persons or categories of persons are not eligible to participate in the promotion or win any prize: any officer or employee of the New York State Division of Lottery, a principal, key employee or employee of any video lottery gaming agent licensed pursuant to this part, except as may be permitted by the Division for good cause shown, any licensee, registrant, contractor, subcontractor, or consultant, or officer or employee of a contractor, subcontractor, licensee, registrant or consultation, if such person is directly involved in the operation of video lottery gaming, the operation or observation of video lottery gaming or drawings, or the processing of video lottery gaming prize claims or payments, any person subject to a contract with the Division if such contract contains a provision prohibiting such person from purchasing a video lottery gaming ticket or receiving a video lottery gaming prize, any officer or employee of RWNY, their affiliates or subsidiaries, any spouse, child, brother, sister, or parent of any of the foregoing persons. This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion. Any such entries are void and the prizes will be forfeited automatically.
17. Each redeemer shall indemnify and hold harmless RWNY, its subsidiaries, affiliates, the State of New York and its agents, officers, employees, the division and director and the agents, officers and employees against any damage, loss, claim or liability arising from his or her participation in this promotion. RWNY, its subsidiaries, affiliates assume no liability of any kind for any property loss or damage or personal injury occurring in connection with any reward.
18. By participating in the promotion, each participant agrees to and acknowledges that they will abide by the official rules, regulations and procedures of the promotion.
19. RWNY Management will resolve any and all disputes concerning any questions that arise in regard to the promotion. In the event of a dispute, New York State law shall govern. The decisions of RWNY Management will be final.
20. Management reserves the right to cancel, change or modify the promotion without notice.
