1. **GR 50+ Club: Tuesdays in October, 2018**
2. Must be a Genting Rewards Club Member at Resorts World Casino New York City (RWNY) and 50 years of age or older on the day of the promotion. Genting Rewards membership is free to all patrons who are 18 years of age or older who present a valid state or federally issued picture I.D. at the Genting Rewards booth. No purchase necessary.

4. Qualified Genting Rewards members are entitled to the following promotions on the promotion dates only:
  - Earn 50 points to redeem a voucher for \$15 in Free Play from 10 am – 4 pm.
  - Earn 50 points to redeem a voucher for a \$10 food voucher from noon – 6 pm.
5. Guests can redeem their vouchers at any Genting Rewards kiosk.
6. Only the guest identified on the voucher will be eligible to claim the offers. Vouchers presented by a person other than the redeemer will be voided and the guest may be rendered ineligible for future promotions.
7. Malfunction of the Genting Rewards Kiosks or vouchers that do not register must be reported immediately and within the parameters of the promotion time.
8. Cannot be combined with any other offer. Limit to one per person per promotion day.
9. Free Play rewards are non-transferable and have no cash value. Free Play rewards are intended for use by the Genting Reward account holder that has the offer redeemed from their account. Any use of the offer by someone other than the account holder is not allowed and could render the account ineligible for future offers.
10. Use of Free Play only with no additional play may reduce or eliminate future offers based on historical play.
11. Vouchers and points are non-transferable.
12. All vouchers are void at the end of each designated promotion period.
13. Falsification of any information renders the winner ineligible for the rewards and forfeits any claim to the reward.

licensee, registrant or consultation, if such person is directly involved in the operation of video lottery gaming, the operation or observation of video lottery gaming or drawings, or the processing of video lottery gaming prize claims or payments, any person subject to a contract with the Division if such contract contains a provision prohibiting such person from purchasing a video lottery gaming ticket or receiving a video lottery gaming prize, any officer or employee of RWNY, their affiliates or subsidiaries, any spouse, child, brother, sister, or parent of any of the foregoing persons. This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion. Any such entries are void and the prizes will be forfeited automatically.

15. Each redeemer shall indemnify and hold harmless RWNY, its subsidiaries, affiliates, the State of New York and its agents, officers, employees, the division and director and the agents, officers and employees against any damage, loss, claim or liability arising from his or her participation in this promotion. RWNY, its subsidiaries, affiliates assume no liability of any kind for any property loss or damage or personal injury occurring in connection with any reward.
16. By participating in the promotion, each participant agrees to and acknowledges that they will abide by the official rules, regulations and procedures of the promotion.
