



## **Bally's Green Machine Drawing**

Bi - Monthly from April – December, 2018

2pm – 8pm

1. **Bally's Green Machine Drawing:** April, June, August, October, and December 2018.
2. Must be a Genting Rewards Club Member at Resorts World Casino New York City (RWNY). Genting Rewards membership is free to all patrons who are 18 years of age or older who present a valid state or federally issued picture I.D. at the Genting Rewards booth. No purchase necessary.

4. All guests who earn 50 points will receive a free entry to the drawing starting from 2pm – 7:45pm on promotion date. A maximum of 5 entries can be earned.

### **Free Play: 2pm-8pm**

- Starting at 2pm, the first 400 guests who earn 50 points can print out a \$15 free play voucher. Free play valid only on Bally Slot Machines.

### **Drawing: 4pm – 8pm**

- Drawing drum will open at 3pm at 2<sup>nd</sup> floor Genting Rewards.
  - Three (3) winners will be drawn on top of the hour to enter the Green Machine to grab as much cash as they can.
  - A total of fifteen (15) winners will be located on each promotion date.
  - Guests have 5 minutes to claim their place at the 2<sup>nd</sup> floor Genting Rewards Counter.
  - Any unclaimed places will be forfeited.
  - Limited to 1x win for each promotion date.
  - Guests must be present to win.
5. Each green machine winner will have 20 seconds in the green machine to grab RWNY cash.
  6. Guests must follow the money machine rules posted in the promotion area. Failure to follow the rules will result in disqualification.
  7. Guests will have a second chance to the green machine after failure to follow the rules at the first attempt, second offense will be disqualified.
  8. Limited to one redemption for each promotion day.
  9. Guests can redeem their vouchers at any Genting Rewards kiosk.
  10. Only the guest identified on the voucher will be eligible to claim the gift. Vouchers presented by a person other than the redeemer will be voided and the guest may be rendered ineligible for future promotions.
  11. Free play must be utilized prior to end of the gaming hours on the redemption date.

12. Free play cannot be exchanged for cash or other rewards and must be played through an eligible VLT on the gaming floor at Resorts World Casino New York City during the valid time period.
13. Malfunction of the Genting Rewards Kiosks or vouchers that do not register must be reported immediately and within the parameters of the promotion time.

16. All vouchers are void at the end of each designated promotion period.

This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion. Any such entries are void and the prizes will be forfeited automatically.
19. Each redeemer shall indemnify and hold harmless RWNY, its subsidiaries, affiliates, the State of New York and its agents, officers, employees, the division and director and the agents, officers and employees against any damage, loss, claim or liability arising from his or her participation in this promotion. RWNY, its subsidiaries, affiliates assume no liability of any kind for any property loss or damage or personal injury occurring in connection with any reward.
