

\$1,000,000 NY Final Slot Tournament (Invite Only) Saturday, August 24, 2019 12pm-4:15pm

- 1. **\$1,000,000 NY Final Slot Tournament:** Saturday, August 24, 2019.
- 2. Must be a Genting Rewards Member at Resorts World Casino New York City (RWNY) and 21 years of age or older on the day of the promotion. Genting Rewards membership is free to all patrons who are 18 years of age or older who present a valid state or federally issued picture I.D. at the Genting Rewards booth. No purchase is necessary.
- 3. Promotion information and rules can be obtained from Genting Rewards and by visiting www.rwnewyork.com.
- 4. Qualified Genting Rewards members or guests are entitled to the following promotions on the promotion day.
- 5. Extended to invited members only.
- 6. Entries will be made available in the kiosk machines from 10am-2pm.
- 7. Check-In is required by presenting the voucher to a promotions representative along with a government issued photo ID at the tournament area between 11:45am-2:45pm located on the 3rd Floor Central Park Space. The following are considered acceptable forms of ID:
 - US / Canadian photo driver's license.
 - US / Canadian photo non-driver's license.
 - US Military/Veteran ID with photo.
 - US / Foreign passport with photo.
- 8. Vouchers are not transferable and have no cash value. Vouchers include: tracking number, guest name, account number, date, expiration date and description of award.
- 9. Guests can only redeem one time per promotion date.
- 10. Voucher must be checked-in the same day in which it is printed.
- 11. Sessions will be filled by a first come, first served basis and machine numbers will be randomly chosen at registration.
- 12. Player totals in each session will vary per hour based on amount of participants during the time of check-in.

13. Tournament Play:

- Play-Offs: ROUND 1 (12pm 3pm):
 - i. There will be 20+ sessions of 15-20 players that will consecutively run, one after the other until all guests who checked in during the allotted time frame participate.
 - ii. Each session will consist of 2 minutes of play.

iii. The top 72 highest scores from Round 1 will advance into Round 2 for our Quarter-Finals round.

• Quarter-Finals: ROUND 2 (3pm – 3:30pm):

- i. There will be 4 sessions of 18 players that will consecutively run one after the other until all Quarter Finals Rounds are completed.
- ii. Each session will consist of 2 minutes of play.
- iii. The top 20 highest scores from Round 2 will advance into Round 3 for our Semi-Finals round.

• Semi-Finals: ROUND 3 (3:45pm)

- i. There will be 2 sessions played, consisting of 10 players each who previously advanced from the Quarter-Finals.
- ii. The session will consist of 3 minutes of play.
- iii. The Top 5 scorers from Session 1 and Session 2 will advance to the Finals round (10 participants total).

• Finals: ROUND 4 (4pm)

- i. There will be 1 sessions played with all 10 participants from the Semi Finals round.
- ii. The session will consist of 3 minutes of play.
- iii. Prize awards will be based on the score of each player. Places will be from the highest to the lowest score.
- iv. Any ties will result in a 2 minute session to determine a clear winner. The other player will be placed as the 2nd place winner, and all other places will be bumped down in the order of their score.
- v. Final prizes will be awarded at approximately 4:15pm.

- 14. Any malfunction during a guest's session that does not result in points earning and/or significantly interrupts their tournament game will be allowed to play in another session time under the discretion of management.
- 15. Must be present to win. Winner names will be posted at the tournament area and announced on the casino floor through the PA system.
- 16. The 1st-3rd place winners will have 10 minutes to claim their cash prizes at the promotions area on the 3rd Floor Central Park Area.

- 17. If the first place winner does not claim their prize, their cash will be forfeited and chance to play in the TournEvent of Champions in Las Vegas will be awarded to the 2nd place winner. All other prizes will be forfeited if the 2nd-3rd place winners do not claim their place.
- 18. All other winners excluding the Final top 10 will receive \$20 Free Play.
- 19. All free play prizes awarded will be uploaded into the player's account by 5pm, and will expire by 6am, September7th, 2019.
- 20. Free play rewards are non-transferable and have no cash value. Free play rewards are intended for use by the Genting Reward account holder that has the offer redeemed from their account. Any use of the offer by someone other than the account holder is not allowed and could render the account ineligible for future offers.
- 21. It is the responsibility of the guest to ensure that their card is properly inserted and that the system identifies them appropriately to qualify for entry.
- 22. Guests can only enter 1 time. Prizes and entries are non-transferable.
- 23. The first place winner must adhere to all rules and regulations correlating with the 2019 TournEvent of Champions, along with their eligibility requirements. If in the event they do not meet these requirements, they will be disqualified to participate in the 2019 TournEvent of Champions and not receive their trip to Las Vegas.
- 24. Guests must register the day they print out their voucher from a Genting Rewards Kiosk machine.
- 25. Winners must present a valid state or federal issued photo identification or passport to claim their prize. Winners are responsible for any United States Federal, State or local taxes. Winners must also present proof of their Social Security Number or complete a W-9 or similar document to comply with Federal tax reporting requirements. - 27. Falsification of any information renders the winner ineligible for the prize and forfeits any claim to the prize.
- 28. By accepting a prize winners grant RWNY the right to use their name, city of residence and photograph for publicity purposes to advertise their winnings without any additional compensation. The name, city of residence and state shall be regarded as public information; however the street address or telephone number of the prize winners will not be released unless required through lawful authority, subpoena or urgent necessity. Photos may be taken for publicity or for a record at the discretion of RWNY.
- 29. Eligibility: The following persons or categories of persons are not eligible to participate in the promotion or win any prize: any officer or employee of the New York State Division of Lottery, a principal, key employee or employee of any video lottery gaming agent licensed pursuant to this part, except as may be permitted by the Division for good cause shown, any licensee, registrant, contractor, subcontractor, or consultant, or officer

or employee of a contractor, subcontractor, licensee, registrant or consultation, if such person is directly involved in the operation of video lottery gaming, the operation or observation of video lottery gaming or drawings, or the processing of video lottery gaming prize claims or payments, any person subject to a contract with the Division if such contract contains a provision prohibiting such person from purchasing a video lottery gaming ticket or receiving a video lottery gaming prize, any officer or employee of RWNY, their affiliates or subsidiaries, any spouse, child, brother, sister, or parent of any of the foregoing persons. This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who have been evicted from the property or who have requested selfexclusion from the property are not eligible to participate in the promotion. Any such entries are void and the prizes will be forfeited automatically.

- 30. Each winner shall indemnify and hold harmless RWNY, its subsidiaries, affiliates, the State of New York and its agents, officers, employees, the division and director and the agents, officers and employees against any damage, loss, claim or liability arising from his or her participation in this promotion. RWNY, its subsidiaries, affiliates assume no liability of any kind for any property loss or damage or personal injury occurring in connection with any prizes.
