1. **Summer Wheels and Cash:** Sunday, June 30, 2019.
2. Must be a Genting Rewards Club Member at Resorts World Casino New York City (RWNY). Genting Rewards membership is free to all patrons who are 18 years of age or older who present a valid state or federally issued picture I.D. at the Genting Rewards booth. No purchase necessary.
3. Promotion information and rules can be obtained from Genting Rewards and by visiting www.rwny.com.
4. Qualified Genting Rewards members are entitled to the following promotions on the promotion day only.

Car Drawing:

- Guests who earn 75 points on any day May 20th – June 29th 2019 may receive one entry for the Jeep Drawing on June 30, 2019.
- Qualified guests must redeem their entry at the Genting Rewards Kiosk machines during the promotional earning period when points are earned or entry will be forfeited.
- Guests are entitled to multiple entries; maximum of one (1) entry per day after point requirement is met during promotional earning period.
- All guests are responsible for their entries, lost or misplaced entries will not be reissued.

Free Play Bonus:

- Any guest who redeemed more than twenty-five (25) entries during the promotion earning period will receive a \$100 free play on the promotion date June 30, 2019.
- All qualified guests may redeem their free play at any Genting Reward Kiosks between 6:30pm-midnight on the drawing date.

Drawing: 6pm

- Drawing drum will open at 3pm at Bar 360.
- **Five (5) winners will be drawn at 6pm.**
- Guests have **10 minutes** to claim their place at Bar 360.
- Any unclaimed places will be redrawn until all 5 places are claimed.
- Limited to 1x win for the promotion day.
- Guests must be present to win.
- Winners will get to choose an envelope off the board in the order that their name was drawn.
- Two (2) winners will receive one car each, along with \$2,500 cash.
- All others will receive cash prizes between \$5,000 – \$10,000.

5. **All 5 claimed winners will also receive a Golden Pass to enter the \$1 Million Dollar New York Qualifier Tournament Final on August 24, 2019 (Winner must be 21 years of age or older to receive pass).**
6. Entries are non-transferable. Entries will have player name and account number. Any player that had been barred or excluded will not be eligible for the drawings.
7. Winners must present a valid state or federal issued photo identification or passport to claim their prize. Winners are responsible for any United States Federal, State or local taxes and/or any fees that may be imposed in connection with the acceptance of any gift or prize. Winners must also present proof of their Social Security Number or complete a W-9 or similar document to comply with Federal tax reporting requirements.
8. Guests can redeem their vouchers at any Genting Rewards kiosk.
9. Only the guest identified on the voucher will be eligible to claim the gift. Vouchers presented by a person other than the redeemer will be voided and the guest may be rendered ineligible for future promotions.
10. Malfunction of the Genting Rewards Kiosks or vouchers that do not register must be reported immediately and within the parameters of the promotion time.
11. Cannot be combined with any other offer. Limit to one per person per promotion day.
12. Free play rewards are non-transferable and have no cash value. Free play rewards are intended for use by the Genting Reward account holder that has the offer redeemed from their account. Any use of the offer by someone other than the account holder is not allowed and could render the account ineligible for future offers.

14. Vouchers and points are non-transferable.
15. All vouchers are void at the end of each designated promotion period.
16. Falsification of any information renders the winner ineligible for the rewards and forfeits any claim to the reward.

Eligibility: The following persons or categories of persons are not eligible to participate in the promotion or win any prize: any officer or employee of the New York State Division of Lottery, a principal, key employee or employee of any video lottery gaming agent licensed pursuant to this part, except as may be permitted by the Division for good cause shown, any licensee, registrant, contractor, subcontractor, or consultant, or officer or employee of a contractor, subcontractor, licensee, registrant or consultation, if such person is directly involved in the operation of video lottery gaming, the operation or observation of video lottery gaming or drawings, or the processing of video lottery gaming prize claims or payments, any person subject to a contract with the Division if such contract contains a provision prohibiting such person from purchasing a video lottery gaming ticket or receiving a video lottery gaming prize, any officer or employee of RWNY, their affiliates or subsidiaries, any spouse, child, brother, sister, or parent of any of the foregoing persons. This section shall not be deemed to prohibit the sale of a video lottery

gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion. Any such entries are void and the prizes will be forfeited automatically.

18. Each redeemer shall indemnify and hold harmless RWNY, its subsidiaries, affiliates, the State of New York and its agents, officers, employees, the division and director and the agents, officers and employees against any damage, loss, claim or liability arising from his or her participation in this promotion. RWNY, its subsidiaries, affiliates assume no liability of any kind for any property loss or damage or personal injury occurring in connection with any reward.
19. By participating in the promotion, each participant agrees to and acknowledges that they will abide by the official rules, regulations and procedures of the promotion.
20. RWNY Management will resolve any and all disputes concerning any questions that arise in regard to the promotion. In the event of a dispute, New York State law shall govern. The decisions of RWNY Management will be final.
