



### **March Earn and Get Gift**

Earn: All March. Redeem: April 5, 2019

1. February Earn and Get Gift: Earn March 1-31, 2019
2. Must be a Genting Rewards Club Member at Resorts World Casino New York City (RWNY).  
Genting Rewards membership is free to all patrons who are 18 years of age or older who present a valid state or federally issued picture I.D. at the Genting Rewards booth.

4. First 1,000 guests who earned 3,500 points between March 1 - 31, 2019 can redeem a voucher for a free gift from 3pm – 7pm on April 5, 2019.

6. Only the guest identified on the voucher will be eligible to claim the gift. Vouchers presented by a person other than the redeemer will be voided and the guest may be rendered ineligible for future promotions.

foregoing persons. This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion. Any such entries are void and the prizes will be forfeited automatically.

15. Each redeemer shall indemnify and hold harmless RWNV, its subsidiaries, affiliates, the State of New York and its agents, officers, employees, the division and director and the agents, officers and employees against any damage, loss, claim or liability arising from his or her participation in this promotion.
