1. **Tier Appreciation Day:** Thursdays in November, 2020
2. Must be a Genting Rewards Club Member at Resorts World Casino New York City (RWNY). Genting Rewards membership is free to all patrons who are 18 years of age or older who present a valid state or federally issued picture I.D. at the Genting Rewards booth. No purchase necessary.

4. Guests will receive a Free Play offer on one of the dates specified below based on their tier level on the day of the promotion.
  - a. November 5<sup>th</sup>- Black Card Members will receive \$100 Free Play.
  - b. November 12<sup>th</sup>- Platinum Card Members will receive \$50 Free Play.
  - c. November 19<sup>th</sup>- Gold Card Members will receive \$25 Free Play.
  - d. November 26<sup>th</sup>- Silver Card Members will receive \$10 Free Play.
5. Free Play must be redeemed on the date given in accordance to the member's card level, or it will be forfeited.
6. Voucher can be redeemed at any operational Genting Rewards kiosk or 2<sup>nd</sup> Floor Slot Machine.
7. Points will not be redeemed to obtain voucher.
8. Free play must be utilized prior to end of the gaming hours on the redemption date.
9. Free play cannot be exchanged for cash or other rewards and must be played through an eligible VLT on the gaming floor at Resorts World Casino New York City during the valid time period.
10. Malfunction of the Genting Rewards Kiosks or vouchers that do not register must be reported immediately and within the parameters of the promotion time.

This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion. Any such entries are void and the prizes will be forfeited automatically.

19. Each redeemer shall indemnify and hold harmless RWNY, its subsidiaries, affiliates, the State of New York and its agents, officers, employees, the division and director and the agents, officers and employees against any damage, loss, claim or liability arising from his or her participation in this promotion.
