1. **Hoopla Slot Tournament:** Saturday, March 30, 2019
2. Must be a Genting Rewards Member at Resorts World Casino New York City (RWNY). Genting Rewards membership is free to all patrons who are 18 years of age or older who present a valid state or federally issued picture I.D. at the Genting Rewards booth. No purchase is necessary.
3. Promotion information and rules can be obtained from Genting Rewards and by visiting [www.rwny.com](http://www.rwny.com).
4. Qualified Genting Rewards members or guests are entitled to the following promotions on the promotion day.
5. Extended to invited members who reached the qualification of being in the top 60<sup>th</sup> places in the Qualifier Hoop-La Slot Tournament on March 23<sup>rd</sup>.
6. Entries will be made available in the kiosk machines from 3pm-4pm.
7. Check-In is required by presenting the voucher to a promotions representative along with a government issued photo ID at the tournament area between 4pm-4:30pm located on the 3rd Floor Central Park Space. The following are considered acceptable forms of ID;
  - US / Canadian photo driver's license.
  - US / Canadian photo non-driver's license.
  - US military ID with photo.
  - US / Foreign passport with photo.
8. Vouchers are not transferable and have no cash value. Vouchers include: tracking number, guest name, account number, date, expiration date and description of award.
9. Guests can only redeem one time per promotion date.
10. Voucher must be checked-in the same day in which it is printed.
11. Sessions will be filled by a first come, first served basis and machine numbers will be randomly chosen at registration.
12. Player totals in each session will vary per hour based on amount of participants during the time of check-in.
13. **Tournament Play:**
  - **Semi-Finals: ROUND 1 (4:45pm – 5:15pm):**
    - i. There will be 4 sessions of 10-15 players that will consecutively run one after the other until all checked in guests participate.
    - ii. Each session will consist of **3 minutes of play.**
    - iii. Each checked in guest will receive \$100 in Free Play before their session begins (\$100 Free Play to be used by 6am on March 31<sup>st</sup>).
    - iv. The top 2 highest scores from each session will advance into Round 2 for our Finals round (8 participants total)

- **Finals: ROUND 2 (5:30pm)**

- There will be 1 session played with all 8 participants from the Semi Finals round.
- The session will consist of 3 minutes of play.
- Prize awards will be based on the score of each player. Places will be from the highest to the lowest score.
- Any ties will result in splitting the prize allocated for the contested place and the following place to each participant.
- Final prizes will be awarded at approximately 5:45pm.

nction during a guest's session that does not result in points earning and/or significantly interrupts their tournament game will be allowed to play in another session time under the discretion of management.

- Must be present to win. Winner names will be posted at the tournament area and announced on the casino floor through the PA system.
- The 1<sup>st</sup>-3<sup>rd</sup> place winners will have 10 minutes to claim their cash prizes at the promotions area on the 3<sup>rd</sup> Floor Central Park Area. If the winner does not claim their prize, it will be forfeited.
- All free play prizes awarded to the 1<sup>st</sup> -8<sup>th</sup> place winners will be uploaded into the player's account by 6:30pm, and will expire by 6am, April 7<sup>th</sup>, 2019.
- Free play rewards are non-transferable and have no cash value. Free play rewards are intended for use by the Genting Reward account holder that has the offer redeemed from their account. Any use of the offer by someone other than the account holder is not allowed and could render the account ineligible for future offers.
- It is the responsibility of the guest to ensure that their card is properly inserted and that the system identifies them appropriately to qualify for entry.
- Guests can only enter 1 time. Prizes and entries are non-transferable.
- Guests must register the day they print out their voucher from a Genting Rewards Kiosk machine.
- Winners must present a valid state or federal issued photo identification or passport to claim their prize. Winners are responsible for any United States Federal, State or local taxes. Winners must also present proof of their Social Security Number or complete a W-9 or similar document to comply with Federal tax reporting requirements. Winners who are present within the 10 minute claim window, and do not have the necessary valid government issues photo ID will have up to 7 days to claim their prize. The following are considered acceptable forms of ID:

  - US / Canadian photo non-driver's license.
  - US military ID with photo.
  - US / Foreign passport with photo.

Eligibility: The following persons or categories of persons are not eligible to participate in the promotion or win any prize: any officer or employee of the New York State Division of Lottery, a principal, key employee or employee of any video lottery gaming agent licensed pursuant to this part, except as may be permitted by the Division for good cause shown, any licensee, registrant, contractor, subcontractor, or consultant, or officer or employee of a contractor, subcontractor, licensee, registrant or consultation, if such person is directly involved in the operation of video lottery gaming, the operation or observation of video lottery gaming or drawings, or the processing of video lottery gaming prize claims or payments, any person subject to a contract with the Division if such contract contains a provision prohibiting such person from purchasing a video lottery gaming ticket or receiving a video lottery gaming prize, any officer or employee of RWNY, their affiliates or subsidiaries, any spouse, child, brother, sister, or parent of any of the foregoing persons. This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion. Any such entries are void and the prizes will be forfeited automatically.
26. Each winner shall indemnify and hold harmless RWNY, its subsidiaries, affiliates, the State of New York and its agents, officers, employees, the division and director and the agents, officers and employees against any damage, loss, claim or liability arising from his or her participation in this promotion. RWNY, its subsidiaries, affiliates assume no liability of any kind for any property loss or damage or personal injury occurring in connection with any prizes.
27. By participating in the promotion, each participant agrees to and acknowledges that they will abide by the official rules, regulations and procedures of the promotion.
28. RWNY Management will resolve any and all disputes concerning any questions that arise in regard to the promotion. In the event of a dispute, New York State law shall govern. The decisions of RWNY Management will be final.
