1. **Earn & Play Tournament:** Every Thursday in June 2018
2. Must be a Genting Rewards Member at Resorts World Casino New York City (RWNY). Genting Rewards membership is free to all patrons who are 18 years of age or older who present a valid state or federally issued picture I.D. at the Genting Rewards booth. No purchase is necessary.
3. Promotion information and rules can be obtained from Genting Rewards and by visiting www.rwny.com.
4. Qualified Genting Rewards members or guests are entitled to the following promotions on the promotion day.
5. Open to all guests who earn 100 points on any Thursday in June 2018 and can redeem an entry into the tournament. (Limited to the first 240 guests to print out a voucher).
6. Guests must check-in by redeeming their voucher at any Marketing kiosk. Registration is required by presenting the voucher to reserve a tournament spot. Tournament is limited to the first 240 guests. Tournament max is 240 participants per tournament date.
7. **Registration:**
 - Registration is required by presenting the voucher to a promotions representative with a valid picture I.D. at the tournament area between 2pm-4pm located on the 3rd Floor Central Park Space.
 - Vouchers are not transferable and have no cash value. Vouchers include: tracking number, guest name, account number, date, expiration date and description of award.
 - Guest can only redeem one time per promotion date.
 - Voucher must be registered the same day in which it is printed.
 - Rounds will be filled in time order and machine numbers will be randomly chosen at registration.
 - Each guest will pick a card that will contain their round time and machine number for play.
 - Rounds will be closed for entry 10 minutes prior to the start of each round time. Any guest who arrives late will be disqualified from the tournament.
8. **Tournament Play:**
 - Guests will be required to be in and seated at their machine upon the start of their round. Guests will not be allowed to participate in play if they arrive after the round has begun and their entry will be considered forfeited.
 - 20 machines including 1 alternate machine will be utilized for tournament play. There will be 19 people scheduled for each round.
 - Each round will consist of 2 minutes of play.
 - Round schedule:

- After each round is completed, the score of each player will be recorded in the tournament system and will be posted on the screen. It is the responsibility of each player to verify and initial that their score has been recorded correctly prior to leaving the tournament area.
- Final prizes are awarded at approximately 7pm.
- Prize awards will be based on the score of each player. Places will be from the highest to the lowest score. Any ties which result from session lay will result in each participant receiving the prize allocated for that place.

9. In the case of a machine malfunction, the guest will be moved to an alternate machine to play a new 2 minute round. All credits from the round prior to malfunction will be voided and not eligible to be part of the tournament score.
10. Must be present to win. Winner names will be posted at the tournament area and announced on the casino floor through the PA system. The 1st-5th winners will have 10 minutes to claim their prizes at the promotions area. If the winner does not claim their prize it will be forfeited.
11. Free play prizes awarded to the 6th-20th winners will expire at the end of gaming day.
12. All other participants (excluding the top 20th places) will receive \$20 in Free Play which will be uploaded into their account. Free play can be redeemed from any Genting Rewards Kiosk after 7:30pm. Free play will expire at the end of gaming day.
13. Free play rewards are non-transferable and have no cash value. Free play rewards are intended for use by the Genting Reward account holder that has the offer redeemed from their account. Any use of the offer by someone other than the account holder is not allowed and could render the account ineligible for future offers.
14. It is the responsibility of the guest to ensure that their card is properly inserted and that the system identifies them appropriately to qualify for entry.
15. Guests can only enter 1 time per promotion date. Prizes and entries are non-transferable.
16. Guests must register the day they print out their voucher from a Genting Rewards Kiosk machine.
17. Winners must present a valid state or federal issued photo identification or passport to claim their prize. Winners are responsible for any United States Federal, State or local taxes. Winners must also present proof of their Social Security Number or complete a W-9 or similar document to comply with Federal tax reporting requirements.

18. Falsification of any information renders the winner ineligible for the prize and forfeits any claim to the prize.
19. By accepting a prize winners grant RWNY the right to use their name, city of residence and photograph for publicity purposes to advertise their winnings without any additional compensation. The name, city of residence and state shall be regarded as public information; however the street address or telephone number of the prize winners will not be released unless required through lawful authority, subpoena or urgent necessity. Photos may be taken for publicity or for a record at the discretion of RWNY.
20. Eligibility: The following persons or categories of persons are not eligible to participate in the promotion or win any prize: any officer or employee of the New York State Division of Lottery, a principal, key employee or employee of any video lottery gaming agent licensed pursuant to this part, except as may be permitted by the Division for good cause shown, any licensee, registrant, contractor, subcontractor, or consultant, or officer or employee of a contractor, subcontractor, licensee, registrant or consultation, if such person is directly involved in the operation of video lottery gaming, the operation or observation of video lottery gaming or drawings, or the processing of video lottery gaming prize claims or payments, any person subject to a contract with the Division if such contract contains a provision prohibiting such person from purchasing a video lottery gaming ticket or receiving a video lottery gaming prize, any officer or employee of RWNY, their affiliates or subsidiaries, any spouse, child, brother, sister, or parent of any of the foregoing persons. This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion. Any such entries are void and the prizes will be forfeited automatically.
21. Each winner shall indemnify and hold harmless RWNY, its subsidiaries, affiliates, the State of New York and its agents, officers, employees, the division and director and the agents, officers and employees against any damage, loss, claim or liability arising from his or her participation in this promotion. RWNY, its subsidiaries, affiliates assume no liability of any kind for any property loss or damage or personal injury occurring in connection with any prizes.
22. By participating in the promotion, each participant agrees to and acknowledges that they will abide by the official rules, regulations and procedures of the promotion.
23. RWNY Management will resolve any and all disputes concerning any questions that arise in regard to the promotion. In the event of a dispute, New York State law shall govern. The decisions of RWNY Management will be final.
24. Management reserves the right to cancel, change or modify the promotion without notice.
25. RWNY is not responsible for typographical or printing errors, or any mechanical or technical malfunctions that may occur during a promotion.
26. Valid at Resorts World Casino New York City only. Promotion is void where prohibited.
