



Bering Watch Giveaway (Invite Only)

1. Must be a Genting Rewards Club member at Resorts World Casino New York City (RWNYC) and be invited to the event based on rated play level. Genting Rewards membership is free to all patrons who are 18 years of age or older who present a valid state or federally issued picture I.D. at the Genting Rewards booth.
2. Gift supply is limited and is distributed on a first-come, first-served basis.
3. The first 1,000 invited guests to redeem a gift voucher from a Genting Rewards Kiosk will receive a Bering Watch from 4pm-10pm.
4. The gift voucher for will be available to print during the specified promotion from 4pm-9:59pm or until the allotment is reached, whichever is earlier.
5. Gift vouchers are exchanged for the gift item at the 1st Floor Promotion Booth and will be overseen by a member of marketing management.
6. All guests presenting a gift voucher must present a valid form of identification that matches the voucher e.g., federal or state-issued ID.
7. Only the guest identified on the voucher will be eligible to claim the gift. Vouchers presented by a person other than the redeemer will be voided and the guest may be rendered ineligible for future promotions.

This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion. Any such entries are void and the prizes will be forfeited automatically.

Each redeemer shall indemnify and hold harmless RWNY, its subsidiaries, affiliates, the State of New York and its agents, officers, employees, the division and director and the agents, officers and employees against any damage, loss, claim or liability arising from his or her participation in this promotion.
