2. Must be a Genting Rewards Club Member at Resorts World Casino New York City (RWNY). Genting Rewards membership is free to all patrons who are 18 years of age or older who present a valid state or federally issued picture I.D. at the Genting Rewards booth. No purchase necessary.

4. Qualified Genting Rewards members or guests are entitled to the following promotions on the promotion day only.

### **Earning Period:**

- Guests who earn 88 points on any Electronic Table Games throughout RWNYC on the promotion day will receive 1 drawing entry between 9am -7:45pm.
  - Guests can receive multiple entries after every 88 points earned.
- Qualified guests must print out their entries from any slot machines (VLTs) on the 2<sup>nd</sup> Floor Fifth Avenue Casino
- All guests are responsible for their entries, lost or misplaced entries will not be reissued.

### **Thankful Cash Rewards Drawing:**

- Drawing drum will open at 2pm outside the Baccarat Club.
- Three (3) names will be drawn every hour starting from 3pm-8pm to win cash prizes ranging from \$500 - \$3,000
- All drawing entries that is deposited into the drum will remain until the last drawing @8pm.
- A total of eighteen (18) winners will be called on the date of the promotion.
- Winner's names will be announced via the PA and posted outside the Baccarat Club.
- Guests have 10 minutes to claim their prize at the promotions table located outside Baccarat Club.
- Limited to 1x win for the promotion date
- Repeated names will be redrawn.
- Must be present to win.
- Any unclaimed prizes will be forfeited.

5. Entries are non-transferable. Entries will have player name and account number. Any player that had been barred or excluded will not be eligible for the drawings.
6. Winners must present a valid state or federal issued photo identification or passport to claim their prize. Winners are responsible for any United States Federal, State or local taxes and/or any fees that may be imposed in connection with the acceptance of any gift or prize. Winners must also present proof of their Social Security Number or complete a W-9 or similar document to comply with Federal tax reporting requirements.
7. Guests can redeem their vouchers at any Genting Rewards kiosk.

with the Division if such contract contains a provision prohibiting such person from purchasing a video lottery gaming ticket or receiving a video lottery gaming prize, any officer or employee of RWNY, their affiliates or subsidiaries, any spouse, child, brother, sister, or parent of any of the foregoing persons. This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion. Any such entries are void and the prizes will be forfeited automatically.

17. Each redeemer shall indemnify and hold harmless RWNY, its subsidiaries, affiliates, the State of New York and its agents, officers, employees, the division and director and the agents, officers and employees against any damage, loss, claim or liability arising from his or her participation in this promotion.
