

\$30K Off to the Races Slot Tournaments Wednesdays & Fridays every week in May beginning May 4th; May 4th & 6th, 11th & 13th, 18th & 20th, 25th & 27th. 3:45pm-6:45pm each Wednesday, 5:45pm-8:45pm each Friday

- 1. **GR Member Slot Tournament**: Wednesdays and Fridays each week in May 2022, beginning May 4th.
- 2. Must be a Genting Rewards Club Member at Resorts World Casino New York City (RWNY) and must have been invited in the RWNY Core Mailer for May 2022.
- 3. Genting Rewards membership is free to all patrons who are 18 years of age or older who present a valid state or federally issued picture I.D. at the Genting Rewards booth. No purchase is necessary.
- 4. Promotion information and rules can be obtained from Genting Rewards and by visiting www.rwnewyork.com.
- 5. Qualified Genting Rewards members or guests are entitled to the following promotions on the promotion day.
- 6. Open to all invited guests to play 2 times per week on both Wednesday and Friday, May 4th-27th.
- 7. Limited to the first 330 guests to print out a voucher each promotion date.
- 8. Vouchers will be made available at red marketing kiosks from 3pm-6:30pm on Wednesday and 5pm-8:30pm on Friday
- 9. Check-In is required by presenting the voucher to a promotions representative along with a state or federally issued government photo ID at the tournament area between 3:45pm-6:45pm on Wednesday and 5:45pm-8:45pm on Friday, located in the 2nd Floor Fifth Avenue Casino, Colony Lounge. The following are considered acceptable forms of ID:
 - US / Canadian photo driver's license.
 - US / Canadian photo non-driver's license.
 - US military/veteran ID with photo.
 - US / Foreign passport with photo.
- 10. Vouchers are not transferable and have no cash value. Vouchers include: tracking number, guest name, account number, date, expiration date and description of award...
- 11. Voucher must be checked-in the same day in which it is printed.

12. **Tournament Play:**

- Sessions will be filled by a first come, first served basis and machine numbers will be randomly chosen at registration.
- Sessions will be approximately every 8 minutes.
- Sessions will vary per hour based on amount of participants during the time of checkin.
- 15 machines including 1 alternate machine will be utilized for tournament play. There will be up to 14 people scheduled for each round.

- Each session, other than the last session of the day, will begin with a minimum of 7 participants.
- Each session will consist of 2 minutes of play.
- The last session of the evening will be around 6:45pm on Wednesdays or 8:45pm on Fridays.
- After each round is completed, the score of each player will be recorded in the tournament system and will be posted on the screen.
- Each session round winner will receive a \$50 Gift Card awarded at the end of the round
- Only sessions with a minimum of 7 players will have a \$50 gift card distributed to the session winner. If a session begins with less than 7 players, there will be no gift card prize awarded for that session.
- Final prizes will be awarded at approximately 7:30pm on Wednesday and 9:30pm on Friday.
- Prize awards will be based on the score of each player. Places will be from the highest to the lowest score. Any ties which result from session lay will result in each participant receiving the prize allocated for that place.

- In addition to the Free Slot Prizes awarded for the top 7 scores at the conclusion of each tournament day, the overall top 5 scores for the week of tournaments will be awarded a cash prize at 9:30pm each Friday at the Tournament Area.
- Players with more than one (1) score in the top 5 will only be paid one cash prize for their highest score for the week.
- Players that only have a score from Wednesday but still place in the top 5, will still be awarded a cash prize on Friday without needing to play in the Friday tournament.
- Cash winners must claim their prize within 10 minutes on Friday, or the prize will be forfeited.

- 13. \$1000, and \$500 FSP Prizes are awarded in \$250 increments over multiple weeks.
- 14. Any malfunction during a guest's session that does not result in points earning and/or significantly interrupts their tournament game will be allowed to play in another session time under the discretion of management.
- 15. Winner names will be posted at the tournament area and announced on the casino floor through the PA system.
- 16. Free play prizes awarded will be uploaded into the player's account by 8pm.
- 17. All free play awarded will expire by the Wednesday or Friday of the following week.
 - I.E. Free Play won on Wednesday May 4th will expire at 5AM on May 11th.
- 18. Free play rewards are non-transferable and have no cash value. Free play rewards are intended for use by the Genting Reward account holder that has the offer redeemed from their account. Any use of the offer by someone other than the account holder is not allowed and could render the account ineligible for future offers.
- 19. It is the responsibility of the guest to ensure that their card is properly inserted and that the system identifies them appropriately to qualify for entry.
- 20. Guests must register the day they print out their voucher from a red marketing kiosk.
- 21. Falsification of any information renders the winner ineligible for the prize and forfeits any claim to the prize.
- 22. By accepting a prize winners grant RWNY the right to use their name, city of residence and photograph for publicity purposes to advertise their winnings without any additional compensation. The name, city of residence and state shall be regarded as public information; however the street address or telephone number of the prize winners will not be released unless required through lawful authority, subpoena or urgent necessity. Photos may be taken for publicity or for a record at the discretion of RWNY.
- 23. Eligibility: The following persons or categories of persons are not eligible to participate in the promotion or win any prize: any officer or employee of the New York State Division of Lottery, a principal, key employee or employee of any video lottery gaming agent licensed pursuant to this part, except as may be permitted by the Division for good cause shown, any licensee, registrant, contractor, subcontractor, or consultant, or officer or employee of a contractor, subcontractor, licensee, registrant or consultation, if such person is directly involved in the operation of video lottery gaming, the operation or observation of video lottery gaming or drawings, or the processing of video lottery gaming prize claims or payments, any person subject to a contract with the Division if

such contract contains a provision prohibiting such person from purchasing a video lottery gaming ticket or receiving a video lottery gaming prize, any officer or employee of RWNY, their affiliates or subsidiaries, any spouse, child, brother, sister, or parent of any of the foregoing persons. This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion. Any such entries are void and the prizes will be forfeited automatically.

- 24. Each winner shall indemnify and hold harmless RWNY, its subsidiaries, affiliates, the State of New York and its agents, officers, employees, the division and director and the agents, officers and employees against any damage, loss, claim or liability arising from his or her participation in this promotion. RWNY, its subsidiaries, affiliates assume no liability of any kind for any property loss or damage or personal injury occurring in connection with any prizes.
