2. Must be a Genting Rewards Club Member at Resorts World Casino New York City (RWNY) and 18 years of age or older on the day of the promotion.  - Additional entries can be earned every 100 points
- Qualified guests must print out their entries from any slot machines (VLTs) on the 2nd Floor 5th Avenue Casino
- Earned entries must be printed on the same day that they are earned
- All earned entries are eligible to be deposited on any of the promotion dates in the month
- Drawing will be conducted in front of Bar 360
- Drawing drum will open at 4pm at Bar 360
- Drawing drum will close at 8pm
- The drum turning process and the drawing of the winning vouchers will begin at 8pm
- A total of Five (5) winners will be called on each promotion date.
 - Winner's names will be announced throughout the property through the PA system.
 - Eligible guests can only win a maximum of one prize on each promotion date.
 - Must be present to win
 - Guests will have 5 minutes to claim their prize at the Bar 360
 - Any unclaimed prize will be redrawn up to 2 more times, and after 3 total players have not claimed, with all 3 having five minutes each to claim, then that particular prize will not be awarded.
- Once all Five (5) winners are present, guests will take turns in the order they were drawn to select randomly placed envelopes with prizes written inside from a foam cutout board.
- Once all Five (5) winners have chosen their envelope, winners will simultaneously open their envelopes to reveal their chosen prize.

This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion. Any such entries are void and the prizes will be forfeited automatically.
10. Each redeemer shall indemnify and hold harmless RWNY, its subsidiaries, affiliates, the State of New York and its agents, officers, employees, the division and director and the agents, officers and employees against any damage, loss, claim or liability arising from his or her participation in this promotion.
