1. **RW 11th Anniversary Car Drawing : Saturday, October 29th, 2022**
2. Must be a Genting Rewards Club Member at Resorts World Casino New York City (RWNY) and 18 years of age or older on the day of the promotion. Genting Rewards membership is free to all patrons who are 18 years of age or older who present a valid state or federally issued picture I.D. at the Genting Rewards booth. No purchase necessary.

Earning:

officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion. Any such entries are void and the prizes will be forfeited automatically.
