1. **April Showers ETG Cash Drawing: Sunday April 16<sup>th</sup> & 30<sup>th</sup> 2023**
2. Must be a Genting Rewards Club Member at Resorts World Casino New York City (RWNY) and 18 years of age or older on the day of the promotion. Genting Rewards membership is free to all patrons who are 18 years of age or older who present a valid state or federally issued picture I.D. at the Genting Rewards booth. No purchase necessary.

**Earning Period:**

- Qualified guests must print out their entries from any slot machines (VLTs) on the 2<sup>nd</sup> Floor Fifth Avenue Casino.
  - Guests can earn one entry for every 38 points earned.
- All guests are responsible for their entries, lost or misplaced entries will not be reissued.

**Drawing:**

- Entries will be available between 9am-5:45pm on the drawing date at any of the slot machines (VLTs) located on the 2<sup>nd</sup> Floor Fifth Avenue Casino.
- Drawing drum will open at 2pm in front of the Baccarat Club.
- Two (2) names will be drawn every hour starting from 3pm-6pm to win cash prizes ranging from \$1,000 - \$3,000.
- All drawing entries will stay in the drum throughout the promotional period
- A total of eight (8) winners will be called on the promotion date.
- Guests have 8 minutes to claim their place at the promotions table located outside Baccarat Club.

This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion. Any such entries are void and the prizes will be forfeited automatically.
16. Each redeemer shall indemnify and hold harmless RWNY, its subsidiaries, affiliates, the State of New York and its agents, officers, employees, the division and director and the agents, officers and employees against any damage, loss, claim or liability arising from his or her participation in this promotion.
