- 1. Fabulous Friday FSP & Luxury Giveaway: Fridays in April, 2023
- 2. Must be a Genting Rewards Club Member at Resorts World Casino New York City (RWNY). Genting Rewards membership is free to all patrons who are 18 years of age or older who present a valid state or federally issued picture I.D. at the Genting Rewards booth.
 - No purchase necessary.

- 4. Qualified Genting Rewards members are entitled to the following promotions on the promotion day only.

Earning Period:

- Guests who earn 100 points gaming throughout the property on Fridays in April (April 7, 14, 21, & 28) between 9am and 7:30pm, may receive one entry for the **drawings on that day.**
 - Guests can earn and receive unlimited multiple entries after every 100 points earned in the same day.
 - Qualified guests must print out their entries from any 2nd floor slot machine.
 - Earned entries must be printed on the same day that are earned or they will be forfeit.
 - Guests are responsible for their entries; lost or misplaced entries will not be reissued.
 - o Entries printed on any day are valid for any of the four drawing days.

This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion. Any such entries are void and the prizes will be forfeited automatically.

- 15. Each redeemer shall indemnify and hold harmless RWNY, its subsidiaries, affiliates, the State of New York and its agents, officers, employees, the division and director and the agents, officers and employees against any damage, loss, claim or liability arising from his or her participation in this promotion.
