- 2. Must be a Genting Rewards Club Member at Resorts World Casino New York City (RWNY) and 18 years of age or older on the day of the promotion. Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion. Any such entries are void ant he prizes will be forfeited automatically.
