

March Mobile Monday Free Slot Play March 2024

- 1. All Genting Rewards members who receive the monthly core offer will be able to print \$10 in Free Slot Play when logging in and connecting to a 2nd floor slot machine with a mobile card via the Resorts World Mobile App.
- 2. Must be a Genting Rewards Club Member at Resorts World Casino New York City (RWNY) and 18 years of age or older on the day of the promotion. Genting Rewards membership is free to all patrons who are 18 years of age or older who present a valid state or federally issued picture I.D. at the Genting Rewards booth. No purchase necessary.
- 3. Individuals who are on the New York State Voluntary Self Exclusion ('VSE') list or the Resorts World Hudson Valley Involuntary Exclusion list are not eligible to participate.
- 4. When? March (4,11,18,25), from 9am-4:59am, each ('Promotional Day').
- 5. How? Genting Rewards members who have already downloaded the Resorts World New York City (RWNY) Mobile App, there are four (4) redemption opportunities to redeem \$10 in Free slot Play. The Promotional Days are March 3, 11, 18, and 25. This Free Slot Play offer must be printed at a VLT / 2nd Floor Slot Machine by using the print feature within the App while the member's mobile device is connected to the VLT / Slot Machine. Vouchers are not valid on ETGs or Video Poker. Vouchers are non-transferable and may not be exchanged for cash.
- 6. Prizes: Ten (\$10) in Free Slot Play. The prize is only valid once per ('Promotional Day').

- 8. The Free Slot Play prize can be redeemed via printing at any 2nd Floor Slot Machine.
- 9. It is the responsibility of the guest to ensure that their mobile card is properly connected via blue tooth, and that the system identifies them appropriately.

foregoing persons. This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who have been evicted from the property or who have requested self-exclusion from the property are not eligible to participate in the promotion. Any such entries are void and he prizes will be forfeited automatically.

- 3. Each redeemer shall indemnify and hold harmless RWNY, its subsidiaries, affiliates, the State of New York and its agents, officers, employees, the division and director and the agents, officers and employees against any damage, loss, claim, or liability arising from his or her participation in this promotion.
