 - RWNY Database will then use a random software function to randomly assign the (5) winners of \$100 FSP, then assign \$5 FSP to all other players on the email add/update list.
 - All players on the list will have their FSP amount communicated via email to the address that was added or updated March 31 through April 29, 2024.
 - All free play for this offer will be made available for redemption at Red Marketing Kiosks and/or 2nd Floor Slot Machines immediately following the email communication, and the offer will be good until it expires on Friday, May 31, 2024, at 5am.
- 6. Qualified FSP earned/won during the period will be added to accounts and communicated via email, and there are no physical or virtual entries associated with this promotion.

This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who are currently excluded from RWNY or are currently self-excluded from any New York State VLT or commercial casino are not eligible to participate in the promotion. Any such entries are void and the prizes will be forfeited automatically.
- 13. Each redeemer shall indemnify and hold harmless RWNY, its subsidiaries, affiliates, the State of New York and its agents, officers, employees, the division and director and the agents, officers and employees against any damage, loss, claim, or liability arising from his or her participation in this promotion.
