

## \$40,000 Picnic in the Park Free Slot Play Drawings Earning Period: 9am – 8pm, Three Friday in June 2024 Drawing: Three Fridays in June June 7, 14, 21 4pm, 5pm, 6pm, 7pm, 8pm, 9pm

- 1. \$40,000 Picnic in the Park Free Slot Play Drawings: First three Fridays in June 2024
- Must be a Genting Rewards Club Member at Resorts World Casino New York City (RWNY) and 18 years of age or older on the day of the promotion. Genting Rewards membership is free to all patrons who are 18 years of age or older. No purchase necessary.
- Winners must present their Genting Rewards card and current, valid photo identification (driver's license, state identification card, or United States passport) to collect a prize. If winner is not a United States citizen; a current, valid consular identification, passport, or alien registration card is required.

- 5. Qualified Genting Rewards members are entitled to the following promotions on the promotion day only.

## Earning Period:

- Guests who earn 100 points gaming throughout the property on the promotion dates in June (June 7, 14, 21) between 9am and 8pm, will receive one entry for the \$40,000 Picnic in the Park Drawings.
  - Guests can earn unlimited entries after every 100 points earned in the same day, until 8pm.
  - All earned vouchers must be printed by 8:30pm the day they are earned, or they will be forfeited.
  - Qualified guests must print out their entries from any 2<sup>nd</sup> floor slot machine.
  - Guests are responsible for their entries; lost or misplaced entries will not be reissued.
  - Entries printed on any day are valid for **any of the three** drawing days.

## Drawing: Fridays in June (June 7, 14, 21) @ 4pm, 5pm, 6pm, 7pm, 8pm, 9pm

- Drawing drum will open at 3pm on each drawing date at Bar 360
- Drawing drum closes every hour, from 4pm to 9pm.
- Six (6) winners will be drawn at the top of every hour.
- Winner's names will be announced via the PA system.

- Winners will have 5 minutes to report to Bar 360 and claim their prize.
- Any unclaimed prize will be redrawn.
  - There will be a maximum of two rounds of redraws for each hourly drawing.
  - Winners who do not arrive to claim their prize within the five minutes will be disqualified from further drawings that evening.
- Must be present to win.
- Once all Six (6) winners are present, guests will take turns in the order they were drawn to select randomly placed envelopes with prizes written inside them. One (1) of the prizes will be for the \$1,000 Free Slot Play and Five (5) other prizes will be for \$250 Free Slot Play each.

- 6. Entries are non-transferable. Entries will have player names and account numbers.
- 7. Winners must present a valid state or federal issued photo identification or passport to claim their prize. Winners are responsible for any United States Federal, State, or local taxes and/or any fees that may be imposed in connection with the acceptance of any gift or prize. Winners must also present proof of their Social Security Number or complete a W-9 or similar document to comply with Federal tax reporting requirements.
  - The following are considered acceptable forms of ID:
    - US / Canadian photo driver's license.
    - US / Canadian photo non-driver's license.
    - US Military/Veteran ID with photo.
    - US / Foreign passport with photo

- 8. Guests can redeem their vouchers at any slot machines (VLT) located on the 2<sup>nd</sup> Floor of the casino.
- 9. Only the guest identified on the voucher will be eligible to claim the gift. Vouchers presented by a person other than the redeemer will be voided and the guest may be rendered ineligible for future promotions.
- 10. The malfunction of the Genting Rewards Kiosks or vouchers that do not register must be reported immediately and within the parameters of the promotion time.
- 11. Cannot be combined with any other offer. Limit to one win per person per promotion day.
- 12. Vouchers and points are non-transferable.
- 13. All vouchers are void at the end of each designated promotion period.
- 14. Falsification of any information renders the winner ineligible for the rewards and forfeits any claim to the reward.
- 15. Free play prizes awarded will be uploaded into the player's account by 9pm.
- 16. All free play awarded will expire the following week.
  - I.E. Free Play won on June 7 will expire at 5AM on June 14.
- 17. Free play rewards are non-transferable and have no cash value. Free play rewards are intended for use by the Genting Reward account holder that has the offer redeemed from their account. Any use of the offer by someone other than the account holder is not allowed and could render the account ineligible for future offers.
- 18. Eligibility: The following persons or categories of persons are not eligible to participate in the promotion or win any prize: any officer or employee of the New York State Division of Lottery, a principal, key employee or employee of any video lottery gaming agent licensed pursuant to this part, except as may be permitted by the Division for good cause shown, any licensee, registrant, contractor, subcontractor, or consultant, or officer or employee of a contractor, subcontractor, licensee, registrant or consultation, if such person is directly involved in the operation of video lottery gaming, the operation or observation of video lottery gaming or drawings, or the processing of video lottery gaming prize claims or payments, any person subject to a contract with the Division if such contract contains a provision prohibiting such person from purchasing a video lottery gaming ticket or receiving a video lottery gaming prize, any officer or employee of RWNY, their affiliates or subsidiaries, any spouse, child, brother, sister, or parent of any of the foregoing persons. This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who are currently excluded from RWNY or are currently self-excluded from any New York State VLT or commercial casino are not eligible to participate in the promotion. Any such entries are void and the prizes will be forfeited automatically.
- 19. Each redeemer shall indemnify and hold harmless RWNY, its subsidiaries, affiliates, the State of New York and its agents, officers, employees, the division and director and the agents, officers and employees against any damage, loss, claim or liability arising from

his or her participation in this promotion. RWNY, its subsidiaries, affiliates assume no liability of any kind for any property loss or damage or personal injury occurring in connection with any reward.

- 20. By participating in the promotion, each participant agrees to and acknowledges that they will abide by the official rules, regulations and procedures of the promotion.
