- 1. Electronic Baccarat Tournament: Sunday April 20th, 2025**
2. Genting Rewards membership is free to all patrons who are 18 years of age or older who present a valid state or federally issued picture I.D. at the Genting Rewards booth. No purchase is necessary.
3. Promotion information and rules can be obtained from Genting Rewards and by visiting www.rwny.com.
4. Qualified Genting Rewards members or guests are entitled to the following promotions on the promotion day.
5. Open to all guests who earn 68 points from any Electronic Table Games on the promotion date.
6. Limited to the first 60 guests on the tournament date to print out a voucher, register, and play on the promotion date.
7. Vouchers will be made available at any machine on 5th Ave Casino, from 2pm-5:20pm.
8. Open to all guests who earn 68 points from any Electronic Table Games on the promotion date to play once for free on tournament date.
9. Check-In is required by presenting the voucher to a marketing representative along with the Genting Rewards membership card at the ETG tournament area between 2:00pm—5:20pm located at the far south end of 2nd Floor Fifth Avenue Casino, left of the Slot Tournament games.
10. Vouchers are not transferable and have no cash value. Vouchers include tracking number, guest name, account number, date, expiration date and description of award.
11. Guests can only redeem one time per promotion day.
12. Entry vouchers are only valid the same date on which they are printed.

Tournament Play:

- A maximum of 10 players will be able to play in each session.
- A minimum of 5 players to begin the tournament in each session.
- A maximum of 60 players will be able to play in the tournament on the promotion date.
- Each session will be spaced 30 minutes apart. The first 5 minutes of each session will be dedicated to a brief introduction, explanation of the rules, and assigning seats.
- Players will be assigned to sessions on a first-come, first-served basis when they register for the tournament and the qualified players can return at the specified time.
 - 1st session begins at 3:00PM

- 2nd session begins at 3:30PM
 - 3rd session begins at 4: 00PM
 - 4th session begins at 4: 30PM
 - 5th session begins at 5: 00PM
 - 6th session begins at 5: 30PM
- Each player will have 10 seconds to choose an avatar that will have no bearing on tournament play outcome.
 - Each player will have 26 seconds to choose 2 lucky rounds prior to play.
 - Each session will be played for 9 rounds/hands of Baccarat.
 - Each player will begin each session with 50,000 credits to play with.
 - Each player will receive 5000 extra credits after round 1.
 - Each player will have 30 seconds to place each bet at the beginning of the tournament session, and after each prior hand is completed.
 - Players must place a wager on either the Player or the Banker every hand and may not wager on the Player and the Banker simultaneously.
 - Failure to place a bet in the allotted time will result in a 1,000 credits auto-bet on the player.
 - There will be 1 second between cards being dealt.
 - There will be a minimum bet of 1,000 credits and a maximum bet of 50,000 credits on the Player or the Banker.
 - There will be a minimum bet of 1000 credits and a maximum bet of 50,000 credits on the Tie.
 - In addition to the main Baccarat bets, there will be a minimum bet of 500 credits and maximum bet of 1000 credits to bet of the following side bets, if player chooses to place one.
 - Any Pair.
 - Super Six.
 - Lucky Nine.
 - The following chip values will be available for betting:
 - 500
 - 1,000
 - 2,500
 - 5,000
 - 10,000
 - 20,000
 - Total session time will vary per session based on the number of participants and speed of play during sessions.
 - 10 machines may be utilized for tournament play.
 - In the event of any machine malfunctions, we will activate 2 standby machines.
 - If more than 2 machines malfunction, then we will have less than 10 players in the session.
 - The last session of the day will begin at 5:30pm.

- During each session, the score of each player will be displayed on the leader board and will be posted on the player screen.
- At the end of each session will announce 5 winners.
- Prize awards will be based on the session score of each player. Places will be from the highest to the lowest score. Any ties which result from tournament play will result in each participant receiving the prize allocated for that place, and then the prize for the next lower place will not be awarded.

1. Any malfunction during a guest's session that does not result in points earning and/or significantly interrupts their tournament game will be allowed to play in another session time under the discretion of management.
2. Winner names will be posted at the tournament area and announced on the casino floor through the PA system.
3. Prizes and entries are non-transferable.
4. Falsification of any information renders the winner ineligible for the prize and forfeits any claim to the prize.
5. By accepting a prize winners grant RWNY the right to use their name, city of residence and photograph for publicity purposes to advertise their winnings without any additional compensation. The name, city of residence and state shall be regarded as public information; however, the street address or telephone number of the prize winners will not be released unless required through lawful authority, subpoena or urgent necessity. Photos may be taken for publicity or for a record at the discretion of RWNY.
6. The following are considered acceptable forms of ID to collecting prize:
 - a. US / Canadian photo driver's license.
 - b. US / Canadian photo non-driver's license.
 - c. US military/veteran ID with photo.
 - d. US / Foreign passport with photo.
7. Eligibility: The following persons or categories of persons are not eligible to participate in the promotion or win any prize: any officer or employee of the New York State Division of Lottery, a principal, key employee or employee of any video lottery gaming agent licensed pursuant to this part, except as may be permitted by the Division for good cause shown, any licensee, registrant, contractor, subcontractor, or consultant, or

officer or employee of a contractor, subcontractor, licensee, registrant or consultant, if such person is directly involved in the operation of video lottery gaming, the operation or observation of video lottery gaming or drawings, or the processing of video lottery gaming prize claims or payments, any person subject to a contract with the Division if such contract contains a provision prohibiting such person from purchasing a video lottery gaming ticket or receiving a video lottery gaming prize, any officer or employee of RWNY, their affiliates or subsidiaries, any spouse, child, brother, sister, or parent of any of the foregoing persons. This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who are currently excluded from RWNY or are currently self-excluded from any New York State VLT or commercial casino are not eligible to participate in the promotion. Any such entries are void and the prizes will be forfeited automatically.

8. Each winner shall indemnify and hold harmless RWNY, its subsidiaries, affiliates, the State of New York and its agents, officers, employees, the division and director and the agents, officers and employees against any damage, loss, claim or liability arising from his or her participation in this promotion. RWNY, its subsidiaries, affiliates assume no liability of any kind for any property loss or damage or personal injury occurring in connection with any prizes.
9. By participating in the promotion, each participant agrees to and acknowledges that they will abide by the official rules, regulations, and procedures of the promotion.
10. RWNY Management will resolve all disputes concerning any questions that arise regarding the promotion. In the event of a dispute, New York State law shall govern. The decisions of RWNY Management will be final.
11. Management reserves the right to cancel, change or modify the promotion without notice.
12. RWNY is not responsible for typographical or printing errors, or any mechanical or technical malfunctions that may occur during a promotion.
13. Valid at Resorts World Casino New York City only. Promotion is void where prohibited.
