1. **Open Road Cadillac Car Drawing: Saturday, April 26, 2025.**
2. Must be a Genting Rewards Club Member at Resorts World Casino New York City (RWNY) and 18 years of age or older on the day of the promotion. Genting Rewards membership is free to all patrons who are 18 years of age or older. No purchase necessary.
3. Winners must present their Genting Rewards card and current, valid photo identification (driver's license, state identification card, or United States passport) to collect a prize. Persons who are currently excluded from RWNY or are currently self-excluded from any New York State VLT or commercial casino are not eligible to participate in the promotion.
