- Must be a Genting Rewards Club Member at Resorts World Casino New York City (RWNY) and 18 years of age or older on the day of the promotion. Genting Rewards membership is free to all patrons who are 18 years of age or older. No purchase necessary.

- 3. Winners must present their Genting Rewards card and current, valid photo identification (driver's license, state identification card, or United States passport) to collect a prize. Earning Period:

- Guests who earn 100 points gaming throughout the property on the promotion dates in July (July 4, 11, 18 & 25) between 9am and 8:30pm, will receive one entry for the \$60,000 Sparkling Free Slot Play Drawings.
 - Guests can earn unlimited entries after every 100 points earned in the same day, until 8:30pm.
 - All earned vouchers must be printed by 9 pm on the day they are earned, or they will be forfeited.
 - Fridays in July, all members are given (1) free entry into the drawing.
 - Guests can play a promotional game on the Everi promotional kiosks once (3) Fridays in the month of July on the drawing date to activate their (1) free entry.
 - Awarded entries must be printed from any 2nd floor slot machine.
 - Qualified guests must print out their entries from any 2nd floor slot machine.
 - Guests are responsible for their entries; lost or misplaced entries will not be reissued.

- Drawing drum will open at 3pm on each drawing date at Bar 360.
- Drawing drum closes every hour, from 4pm to 8pm and then finally at 9:15pm.
 - Six (6) winners will be drawn at the top of every hour through 8pm and then finally at 9:15pm.
- Winner's names will be announced via the PA system.
 - Winners will have 5 minutes to report to Bar 360 and claim their prize.
 - Any unclaimed prize will be redrawn. There will be a maximum of two rounds of redraws for each drawing.

- 6. Entries are non-transferable. Entries will have player names and account numbers.
- 7. Winners must present a valid state or federal issued photo identification or passport to claim their prize. Winners are responsible for any United States Federal, State, or local taxes and/or any fees that may be imposed in connection with the acceptance of any gift or prize. This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who are currently excluded from RWNY or are currently self-excluded from any New York State VLT or commercial casino are not eligible to participate in the promotion. Any such entries are void and the prizes will be forfeited automatically.

- 19. Each redeemer shall indemnify and hold harmless RWNY, its subsidiaries, affiliates, the State of New York and its agents, officers, employees, the division and director and the agents, officers and employees against any damage, loss, claim or liability arising from his or her participation in this promotion.
