- 1. Summer Breeze Airline Voucher Giveaway: July 6th & 20th, 2025
- 2. Must be a Genting Rewards Club Member at Resorts World Casino New York City (RWNY) and 18 years of age or older on the day of the promotion. Genting Rewards membership is free to all patrons who are 18 years of age or older. No purchase necessary.
- 3. Winners must present their Genting Rewards card and current, valid photo identification (driver's license, state identification card, or United States passport) to collect a prize. If winner is not a United States citizen; a current, valid consular identification, passport, or alien registration card is required.

- Qualified guests must print out their entries from any machines on the 2nd Floor Fifth Avenue Casino.
 - Guests can earn one entry for every 88 points earned.
- Earned entries must be printed on the same day that they are earned.
- All guests are responsible for their entries, lost or misplaced entries will not be reissued.

Drawing:

- The drawing drum will open at 4pm outside of the baccarat club.
- Three (3) names will be drawn at 6pm to win airline vouchers.
- Guests have 8 minutes to claim their place at the promotions table located outside of the Baccarat Club.

- 9. Only the guest identified on the voucher will be eligible to claim the gift. Vouchers presented by a person other than the redeemer will be voided and the guest may be rendered ineligible for future promotions.
- 10. The malfunction of the Genting Rewards Kiosks or vouchers that do not register must be reported immediately and within the parameters of the promotion time.

This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the

Division or a lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. People who are currently excluded from RWNY or are currently self-excluded from any New York State VLT or commercial casino are not eligible to participate in the promotion. Any such entries are void and the prizes will be forfeited automatically.

- 16. Each redeemer shall indemnify and hold harmless RWNY, its subsidiaries, affiliates, the State of New York and its agents, officers, employees, the division and director and the agents, officers and employees against any damage, loss, claim, or liability arising from his or her participation in this promotion. RWNY, its subsidiaries, affiliates assume no liability of any kind for any property loss or damage or personal injury occurring in connection with any reward.
