1. **Summer Breeze Airline Voucher Giveaway: July 6<sup>th</sup> & 20<sup>th</sup>, 2025**
2. Must be a Genting Rewards Club Member at Resorts World Casino New York City (RWNY) and 18 years of age or older on the day of the promotion. Genting Rewards membership is free to all patrons who are 18 years of age or older. No purchase necessary.
3. Winners must present their Genting Rewards card and current, valid photo identification (driver's license, state identification card, or United States passport) to collect a prize. If winner is not a United States citizen; a current, valid consular identification, passport, or alien registration card is required.

**Earning Period:**

- Guests who play and earn 88 points on any electronic table games throughout RWNY between July 1<sup>st</sup> to 6<sup>th</sup> 5:30PM will receive one entry to the drawing.
- Guests who play and earn 88 points on any electronic table games throughout RWNY between July 14<sup>th</sup> to 20<sup>th</sup> 5:30PM will receive one entry to the drawing.
- Qualified guests must print out their entries from any machines on the 2<sup>nd</sup> Floor Fifth Avenue Casino.
  - Guests can earn one entry for every 88 points earned.
- Earned entries must be printed on the same day that they are earned.
- All guests are responsible for their entries, lost or misplaced entries will not be reissued.

**Drawing:**

- The drawing drum will open at 4pm outside of the baccarat club.
- Three (3) names will be drawn at 6pm to win airline vouchers.
- Guests have 8 minutes to claim their place at the promotions table located outside of the Baccarat Club.
- Limited to 1 win per promotion date.
- Any repeated names or unclaimed places will be redrawn until a winner is found.
- Must be present to win.
- The certificate is non-transferable.
- Winners must contact the travel agency listed on the certificate to redeem the voucher; it cannot be used elsewhere.

- Entries are non-transferable. Entries will have the player's name and account number. Any player that has been barred or excluded will not be eligible for the drawings.
- Winners must present a valid state or federal issued photo identification or passport to claim their prize. Winners are responsible for any United States Federal, State, or local taxes and/or any fees that may be imposed in connection with the acceptance of any gift or prize. Winners must also present proof of their Social Security Number or complete a W-9 or similar document to comply with Federal tax reporting requirements.
  - The following are considered acceptable forms of ID:
    - US / Canadian photo driver's license.
    - US / Canadian photo non-driver's license.
    - US Military/Veteran ID with photo.
    - US / Foreign passport with photo.
- Guests can redeem their vouchers at any slot machines (VLT) located on the 2<sup>nd</sup> Floor 5<sup>th</sup> Ave. casino.
- Only the guest identified on the voucher will be eligible to claim the gift. Vouchers presented by a person other than the redeemer will be voided and the guest may be rendered ineligible for future promotions.
- The malfunction of the Genting Rewards Kiosks or vouchers that do not register must be reported immediately and within the parameters of the promotion time.
- It cannot be combined with any other offer. Limit to one per person per promotion day.
- Vouchers and points are non-transferable.
- All vouchers are void at the end of each designated promotion period.

This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the

Division or a lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. People who are currently excluded from RWNY or are currently self-excluded from any New York State VLT or commercial casino are not eligible to participate in the promotion. Any such entries are void and the prizes will be forfeited automatically.

16. Each redeemer shall indemnify and hold harmless RWNY, its subsidiaries, affiliates, the State of New York and its agents, officers, employees, the division and director and the agents, officers and employees against any damage, loss, claim, or liability arising from his or her participation in this promotion.
