

- 1. Who can enter? New Genting Rewards members who are 18 years of age and older with a Genting Rewards Card. Individuals who are on the New York State Voluntary Self Exclusion ('VSE') list, or the Resorts World Catskills, Hudson Valley or New York City Involuntary Exclusion list are not eligible to participate.

Persons who have been evicted from the property or who have requested selfexclusion from the property are not eligible to participate in the promotion.
