1. **The 14th Year Anniversary Celebration Cash Drawing:** Friday October 31st, 2025
2. Must be a Genting Rewards Club Member at Resorts World Casino New York City (RWNY). Genting Rewards membership is free to all patrons who are 18 years of age or older who present a valid state or federally issued picture I.D. at the Genting Rewards booth. No purchase necessary.

Earning Period:

gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. People who are currently excluded from RWNY or are currently self-excluded from any New York State VLT or commercial casino are not eligible to participate in the promotion. Any such entries are void and the prizes will be forfeited automatically.

Each redeemer shall indemnify and hold harmless RWNY, its subsidiaries, affiliates, the State of New York and its agents, officers, employees, the division and director and the agents, officers and employees against any damage, loss, claim, or liability arising from his or her participation in this promotion.
