1. On every Friday, Genting Rewards members will have the opportunity to redeem up to 40,000 Genting Rewards points for Free Slot Play.
2. Must be a Genting Rewards Club Member at Resorts World Casino New York City (RWNYC) and 21 years of age or older on the day of the promotion. Genting Rewards membership is free to all patrons who are 21 years of age or older who present a valid state or federally issued picture I.D. at the Genting Rewards booth. No purchase necessary.

4. All Genting Rewards members with at least 5,000 Genting Rewards points are eligible to exchange their points **once on every Friday**.
 - Guests who wish to participate may visit the 2nd Floor Genting Rewards Counter from 9am – 12am to redeem their points for Free Slot Play based on the chart below.
 - A form will be provided by Genting Rewards requiring the signature of the Genting Rewards account holder.

5. Free Slot Play prize will be facilitated to card members at the 2nd Floor Genting Rewards counter.
6. Any use of the offer by someone other than the account holder is not allowed and could render the account ineligible for future offers.
7. Falsification of any information renders the winner ineligible for the prize and forfeits any claim to the prize.
8. By accepting a prize winners grant RWNYC the right to use their name, city of residence and photograph for publicity purposes to advertise their winnings without any additional compensation. RWNYC, their affiliates or subsidiaries, any spouse, child, brother, sister, or parent of any of the foregoing persons. This section shall not be deemed to prohibit the sale of a gaming ticket or the payment of a gaming prize to an officer or employee of the Commission or a gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Commission. Persons who are currently excluded from RWNYC or are currently self-excluded from any New York State VLT or Commercial Casino are not eligible to participate in the promotion. Any such entries are void, and the prizes will be forfeited automatically.

Each winner shall indemnify and hold harmless RWNYC, its subsidiaries, affiliates, the State of New York and its agents, officers, employees, the Commission and its agents, officers, and employees against any damage, loss, claim, or liability arising from his or her participation in this promotion.
