1. **Born to Perform Cadillac Drawing: Saturday, April 25, 2026.**
2. Must be a Genting Rewards Club Member at Resorts World Casino New York City (RWNY) and 21 years of age or older on the day of the promotion. Genting Rewards membership is free to all patrons who are 21 years of age or older. No purchase necessary.

This section shall not be deemed to prohibit the sale of a video lottery gaming ticket or the payment of a video lottery gaming prize to an officer or employee of the Division or a lottery gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who are currently excluded from RWNY or are currently self-excluded from any New York State VLT or commercial casino are not eligible to participate in the promotion. Any such entries are void and the prizes will be forfeited automatically.
