1. Must be a Genting Rewards Club Member at Resorts World Casino New York City (RWNY) and 21 years of age or older on the day of the promotion. Genting Rewards membership is free to all patrons who are 21 years of age or older. No purchase necessary.

not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Director. Persons who are currently excluded from RWNY or are currently self-excluded from any New York State VLT or commercial casino are not eligible to participate in the promotion. Any such entries are void and the prizes will be forfeited automatically.
