



**\$10,000 End of Summer Cash Slot Tournaments**  
**Fridays in August 2026**  
**1:45pm-4:45pm**

1. Must be a Genting Rewards Club Member at Resorts World Casino New York City (RWNY).
2. Genting Rewards membership is free to all patrons who are 21 years of age or older who present a valid state or federally issued picture I.D. at the Genting Rewards booth. No purchase is necessary.
3. Promotion information and rules can be obtained from Genting Rewards and by visiting [www.rwny.com](http://www.rwny.com).
4. Qualified Genting Rewards members or guests are entitled to the following promotions on the promotional day.
5. Open to all invited guests to play once for free on each tournament date.
  - **Guests that are not invited may earn an entry to the tournament by earning 500 points on the promotional day and printing a voucher from a Promotional Kiosk before 4:30pm.**
6. Limited to the first 500 vouchers printed on each promotion date.
7. Vouchers will be made available at Promotional Kiosks from 1pm-4:30pm on each tournament day.
8. Check-In is required by presenting the voucher to a Promotions representative along with a state or federally issued government photo ID at the tournament area between 1:45pm-4:45pm, located on the 2<sup>nd</sup> Floor Colony Lounge. The following are considered acceptable forms of ID:
  - US / Canadian photo driver's license.
  - US / Canadian photo non-driver's license.
  - US military/veteran ID with photo.
  - US / Foreign passport with photo.
9. Vouchers are not transferable and have no cash value. Vouchers include tracking number, guest name, account number, date, expiration date and description of award.
10. Vouchers must be checked in the same day on which they are printed.
11. **Tournament Play:**
  - Sessions will be filled based on a first-come, first-served basis and machine numbers will be randomly chosen at registration.
  - Sessions will vary per hour based on the number of participants during the time of check-in.
  - Each session, other than the last session of the day, will begin with a minimum of 7 participants.
  - Each session will consist of 2 minutes of play.

- The last session will be at 4:45pm.
- After each round is completed, the score of each player will be recorded in the tournament system and posted on the screen.
- Each eligible session winner will receive \$50 Free Slot Play (FSP), awarded at the end of each round.
- Only sessions with a minimum of 7 players will have a \$50 FSP prize awarded to the session winner. If a session begins with less than 7 players, there will be no FSP prize awarded for that session.
  - The last session of the day may be awarded the \$50 FSP prize at the discretion of the Promotional Manager, even with fewer than (7) players.
- Final prizes will be awarded at approximately 5:30pm.
- **Monthly Prizes:**
  - Guests who participate and play more than one Friday will have their two highest scores combined; and monthly winners will be announced following the last Friday tournament of the month at 5:30pm.**
  - Any unclaimed monthly prize winner will be notified via phone call and/or email and have up to the following Friday (1 week from the last tournament date) before 5:30 pm to claim the prize with valid photo ID.**

- Daily Free Slot Play prize awards will be based on the placement of the ten highest daily scores. Any ties which result from session play will result in both participants receiving the prize allocated for that place.

12. Any malfunction during a player's session that does not result in points earning and/or significantly interrupts their tournament game will be allowed to play in another session at the discretion of the Promotional Manager.
13. Winner names will be posted at the tournament area and announced on the casino floor through the PA system.
14. Daily Free Slot Play prizes will be awarded by 5:30pm.
15. All Free Slot Play awarded will expire the following week.
  - Example: Free Slot Play won on June 12 will expire at 6am on June 19.
16. Free play rewards are non-transferable and have no cash value. Free play rewards are intended for use by the Genting Reward account holder that has the offer redeemed from their account. Any use of the offer by someone other than the account holder is not allowed and could render the account ineligible for future offers.
17. It is the responsibility of the guest to ensure that their card is properly inserted, and that the system identifies them appropriately to qualify for entry.
18. Falsification of any information renders the winner ineligible for the prize and forfeits any claim to the prize.
19. By accepting a prize winners grant RWNy the right to use their name, city of residence and photograph for publicity purposes to advertise their winnings without any additional compensation. The name, city of residence and state shall be regarded as public information; however, the street address or telephone number of the prize winners will not be released unless required through lawful authority, subpoena, or urgent necessity. Photos may be taken for publicity or for a record at the discretion of RWNy.
20. Eligibility: The following persons or categories of persons are not eligible to participate in the promotion or win any prize: any officer or employee of the New York State Gaming Commission, a principal, key employee or employee of any gaming agent licensed pursuant to

this part, except as may be permitted by the Commission for good cause shown, any licensee, registrant, contractor, subcontractor, or consultant, or officer or employee of a contractor, subcontractor, licensee, registrant or consultation, if such person is directly involved in the operation of gaming, the operation or observation of gaming or drawings, or the processing of gaming prize claims or payments, any person subject to a contract with the Commission if such contract contains a provision prohibiting such person from purchasing a gaming ticket or receiving a gaming prize, any officer or employee of RWNYS, their affiliates or subsidiaries, any spouse, child, brother, sister, or parent of any of the foregoing persons. This section shall not be deemed to prohibit the sale of a gaming ticket or the payment of a gaming prize to an officer or employee of the Commission or a gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Commission. Persons who are currently excluded from RWNYS or are currently self-excluded from any New York State VLT or Commercial Casino are not eligible to participate in the promotion. Any such entries are void, and the prizes will be forfeited automatically.

21. Each winner shall indemnify and hold harmless RWNYS, its subsidiaries, affiliates, the State of New York and its agents, officers, employees, the Commission and its agents, officers, and employees against any damage, loss, claim, or liability arising from his or her participation in this promotion. RWNYS, its subsidiaries, and affiliates assume no liability of any kind for any property loss or damage or personal injury occurring in connection with any prizes.
22. By participating in the promotion, each participant agrees to and acknowledges that they will abide by the official rules, regulations, and procedures of the promotion.
23. RWNYS Management will resolve all disputes concerning any questions that arise regarding the promotion. In the event of a dispute, New York State law shall govern. The decisions of RWNYS Management will be final.
24. Management reserves the right to cancel, change or modify the promotion without notice.
25. RWNYS is not responsible for typographical or printing errors, or any mechanical or technical malfunctions that may occur during a promotion.
