



Earn to Get Free Slot Play
Monday, Tuesdays, and Wednesdays

1. Must be a Genting Rewards Club Member at Resorts World Casino New York City (RWNYC) and 21 years of age or older on the day of the promotion. Genting Rewards membership is free to all patrons who are 21 years of age or older who present a valid state or federally issued picture I.D. at the Genting Rewards booth. No purchase necessary.
2. On Mondays, Tuesdays, and Wednesdays, Genting Rewards members may redeem a \$5 Free Slot Play offer at any slot machine for every 100 points earned in that gaming day.
 - Free Slot Play Redemptions will be loaded on to the Genting Rewards card for use at any Slot Machine at Resorts World New York City and will expire in one day.
 - This is not an exchange of points, but a reward of Free Slot Play.
3. Any use of the offer by someone other than the account holder is not allowed and could render the account ineligible for future offers.
4. Falsification of any information renders the participant ineligible for the prize and forfeits any claim to the prize.
5. By accepting a prize winners grant RWNYC the right to use their name, city of residence and photograph for publicity purposes to advertise their winnings without any additional compensation. The name, city of residence and state shall be regarded as public information; however, the street address or telephone number of the prize winners will not be released unless required through lawful authority, subpoena, or urgent necessity. Photos may be taken for publicity or for a record at the discretion of RWNYC.
6. Eligibility: The following persons or categories of persons are not eligible to participate in the promotion or win any prize: any officer or employee of the New York State Gaming Commission, a principal, key employee or employee of any gaming agent licensed pursuant to this part, except as may be permitted by the Commission for good cause shown, any licensee, registrant, contractor, subcontractor, or consultant, or officer or employee of a contractor, subcontractor, licensee, registrant or consultation, if such person is directly involved in the operation of gaming, the operation or observation of gaming or drawings, or the processing of gaming prize claims or payments, any person subject to a contract with the Commission if such contract contains a provision prohibiting such person from purchasing a gaming ticket or receiving a gaming prize, any officer or employee of RWNYC, their affiliates or subsidiaries, any spouse, child, brother, sister, or parent of any of the foregoing persons. This section shall not be deemed to prohibit the sale of a gaming ticket or the payment of a gaming prize to an officer or employee of the Commission or a gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Commission. Persons who are currently excluded from RWNYC or are currently self-excluded from any New York State VLT or Commercial Casino are not eligible to participate in the promotion. Any such entries are void, and the prizes will be forfeited automatically.

7. Each participant shall indemnify and hold harmless RWNYS, its subsidiaries, affiliates, the State of New York and its agents, officers, employees, the Commission and its agents, officers, and employees against any damage, loss, claim, or liability arising from his or her participation in this promotion. RWNYS, its subsidiaries, and affiliates assume no liability of any kind for any property loss or damage or personal injury occurring in connection with any prizes.
8. By participating in the promotion, each participant agrees to and acknowledges that they will abide by the official rules, regulations, and procedures of the promotion.
9. RWNYS Management will resolve all disputes concerning any questions that arise regarding the promotion. In the event of a dispute, New York State law shall govern. The decisions of RWNYS Management will be final.

11. RWNYS is not responsible for typographical or printing errors, or any mechanical or technical malfunctions that may occur during a promotion.
