1. Must be a Genting Rewards Club Member at Resorts World Casino New York City (RWNYC) and 21 years of age or older on the day of the promotion. Genting Rewards membership is free to all patrons who are 21 years of age or older. No purchase necessary.

 1. Card swipe at any Promotional Kiosk
 2. Rated play on Genting Rewards card at any table or slot machine.

- Winners' names will be announced via the PA system. Announcements may not be heard in all areas of the casino and it is the winners' responsibility to find out if they are a winner.
