



Tier Card Match
August 17 – September 30, 2026

1. **New or inactive** members may present their Rewards Card from Competitor Casinos to Genting Rewards or a member of Casino Marketing to receive a Genting Rewards card deemed to be a similar level, and receive a Free Slot Play or Free Bet offer based on their evaluated play.
2. Must be a **new or inactive** Genting Rewards Club Member at Resorts World Casino New York City (RWNYC).
3. Genting Rewards membership is free to all patrons who are 21 years of age or older who present a valid state or federally issued picture I.D. at the Genting Rewards booth. No purchase necessary.
4. The Genting Rewards card tier awarded will be based on the closest equivalent level to the competitor casino rewards program tier.
 - a. For Example; A guest presenting the highest tier of card from a competitor casino may be awarded the highest tier card for Genting Rewards.
5. Upon receiving the matched Genting Rewards card upgrade, guests may receive a Free Bet or Free Slot Play offer to their card based on their estimated play.
 - a. Guests may receive only **one** of these offers and the type of offer received is based on their choice.
6. Any use of the offer by someone other than the account holder is not allowed and could render the account ineligible for future offers.
7. Falsification of any information renders the participant ineligible for the prize and forfeits any claim to the prize.
8. Eligibility: The following persons or categories of persons are not eligible to participate in the promotion or win any prize: any officer or employee of the New York State Gaming Commission, a principal, key employee or employee of any gaming agent licensed pursuant to this part, except as may be permitted by the Commission for good cause shown, any licensee, registrant, contractor, subcontractor, or consultant, or officer or employee of a contractor, subcontractor, licensee, registrant or consultation, if such person is directly involved in the operation of gaming, the operation or observation of gaming or drawings, or the processing of gaming prize claims or payments, any person subject to a contract with the Commission if such contract contains a provision prohibiting such person from purchasing a gaming ticket or receiving a gaming prize, any officer or employee of RWNYC, their affiliates or subsidiaries, any spouse, child, brother, sister, or parent of any of the foregoing persons. This section shall not be deemed to prohibit the sale of a gaming ticket or the payment of a gaming prize to an officer or employee of the Commission or a gaming agent or to a contractor, subcontractor, or consultant or to an officer or employee of a contractor, subcontractor, or consultant if such sale or prize payment is not for the individual benefit of such person and is made in connection with an official investigation, audit, or other activity authorized by the Commission. Persons who are currently excluded from RWNYC or are currently self-excluded from any New York State VLT or Commercial Casino are not eligible to participate in the promotion. Any such entries are void, and the prizes will be forfeited automatically.

9. Each participant shall indemnify and hold harmless RWNYS, its subsidiaries, affiliates, the State of New York and its agents, officers, employees, the Commission and its agents, officers, and employees against any damage, loss, claim, or liability arising from his or her participation in this promotion. RWNYS, its subsidiaries, and affiliates assume no liability of any kind for any property loss or damage or personal injury occurring in connection with any prizes.
10. By participating in the promotion, each participant agrees to and acknowledges that they will abide by the official rules, regulations, and procedures of the promotion.
11. RWNYS Management will resolve all disputes concerning any questions that arise regarding the promotion. In the event of a dispute, New York State law shall govern. The decisions of RWNYS Management will be final.
