Persons who are currently excluded from RWNYC or are currently self-excluded from any New York State VLT or Commercial Casino are not eligible to participate in the promotion. Any such entries are void, and the prizes will be forfeited automatically.

Each winner shall indemnify and hold harmless RWNYC, its subsidiaries, affiliates, the State of New York and its agents, officers, employees, the Commission and its agents, officers, and employees against any damage, loss, claim, or liability arising from his or her participation in this promotion.
